SD Unified Judicial System Website Redevelopment & Maintenance February 23, 2024

1. Question:

4.0 Project Development platforms

Application must be developed in the Microsoft Technology Stack (Asp.net, Razor, MVC, etc). The CMS recommended is Umbraco, for any other CMS to be considered, they must be within the Microsoft Technology Stack. Database (for the data repository) must be MS SQL or MS compliant database.

Would UJS consider using the existing ServiceNow implementation and licensing already provided for all employees within the state, including the content management solution that exists as a part of that, for this initiative? Or is this Microsoft requirement firm?

Response:

Yes, ServiceNow is an acceptable technical solution.

2. Question:

Section 3.2, #4 – is the expectation that these sites would be moved onto the platform, or does the option exist to link out to existing sites?

Response:

The option to link to existing sites is available and expected.

3. Question:

Response:

The UJS envisions this workgroup as co-lead by the UJS and the vendor with the UJS bringing to the table the content and website needs and the vendor bringing content vision and design elements to achieve those goals. Both UJS and vendor participants would be expected to test the website throughout the process.

EpiServer - Optimizely is a very popular and effective CMS framework, and our team can deliver large-scale applications. May we propose Episerver for this development, or is Umbraco your firm decision, and unlikely that an alternative like Episerver would be successful?

Response:

The AddSearch Tool is installed although the project scope includes providing a more advanced approach.

27. Question:

What challenges are you facing with the current website that you want to address with this contract?

Response:

Overall navigation concerns and inability to find cases, court information, and pro se assistance; difficulty searching and finding the correct information; look of the website is outdated and not visually appealing; and multiple questions from the public and media to locate court information, publications, and resources.

28. Question:

Is the project expected to be performed onsite or be performed from a remote location?

Response:

The work can be performed remotely.

29. Question:

What total number of pages are you looking to have on the website?

Response:

This will be determined by content, format, and layout that is agreed upon by the vendor and UJS workgroup.

Response:

Yes, this is a new contract.

Response:

Response:

The last website redesign was in 2017 and the goals were to streamline and update the design. The website has been maintained since that time.

38. Question:

Who was the previous vendor, and how long was the website under their maintenance?

Response:

No previous vendor, internally completed and maintained.

39. Question:

How many staff members from the authority will be involved in managing the website's content, and do they have experience with the Umbraco CMS?

Response:

This is to be determined, but likely 4-6. Previous experience with a CMS is limited.

40. Question:

What amount of training is anticipated for the team managing the website?

Response:

4-8 hours of training to ensure staff can properly use the CMS.

41. Question:

Regarding ADA compliance, would a level AA suffice, or is there a requirement for AAA compliance as mentioned in the RFP?

Response:

Level AAA is required.

42. Question:

Could you specify the types of maintenance activities you anticipate being most necessary? (e.g., ADA compliance, SEO, performance optimization, bug fixes, plugin upgrades, template adjustments, content issues, etc.)

Response:

Most maintenance activities will be bug fixes, template adjustments and content issues/management.

43. Question:

Has the deployment environment been set up with staging and production instances?

Response:

If the selected solution is hosted in the SD environment the staging and production instances will be requested at necessary times with agreed specifications.

UJS does note have a vendor accessible issue tracking system.

Have there been any major outages or events requiring support outside the standard 9-5 PM PST time frame? If so, could you provide details?

Response:

The State Court Administrator Office operates in CST. Support instances outside the 8:00 a.m. – 5:00 p.m. time frame have been infrequent.

49. Question:

How regularly are plugin upgrades performed, and when was the last upgrade?

Response:

Updates are based on added functionality and meeting the security scan requirements.'

50. Question:

What are the current versions of Umbraco and the .NET framework in use, and what versions are you planning to upgrade to?

Response:

If this is your recommendation, we are willing to discuss this as an option.

Is multi-language support a requirement for the website?

Response:

The existing website utilizes Google Translate functionality.
