The South Dakota Department of the Military is soliciting Statements of Interest from firms interested in providing professional Architectural and Engineering design services for the 466501 – Renovate Generals Quarters on Camp Rapid project located at 2823 W. Main Street, Rapid City, South Dakota 57702.

This project will involve site investigative, design development, and bidding services for renovating an existing quarter. Modifications to bring the building ADA accessible with interior and exterior upgrades. Complete interior changes to room locations, kitchen layout, stair position, and bathrooms. Additional services such as construction administration/inspection will be negotiated at a later date should the project proceed to the construction phase.

- 4. Proposed project management techniques. (10%);
- 5. Proposed QA/QC process for development of construction plans and verifying owner requirements are met (10%);
- 6. Availability to the project locale (10%);
- 7. Familiarity with the project facility (10%);
- 8. Resources available to perform the work, including any specialized services and their roles within the project, within the specified time limits for the project. Resumes of team member's professional accomplishments and experience with similar projects to be included. (20%);
- 9. Record of past performance, including price, schedule, and cost data from previous projects, quality of work, ability to meet schedules, cost control, and contract administration. All projects within the last 5 years with the Dept. of the Military must be included. (10%).
