PURPOSE OF REQUEST FOR PROPOSAL (RFP)

The South Dakota Department of Transportation (SDDOT) desires to purchase wetland credits in order to satisfy wetland mitigation required by the United States Army Corps of Engineers (USACE) as determined during the Clean Water Act Section 404 permitting process (404 permit) for the entire South Veteran's Parkway (SVP) project. SDDOT desires to purchase said credits from a USACE permitted commercial mitigation bank or In-Lieu-Fee (ILF) program having available credit in the Lower Big Sioux Geographic Service Area. Required credits are listed in the Scope of Work, attached hereto as Section 3 of the RFP and by references incorporated herein.
