1.1 PURPOSE OF REQUEST FOR PROPOSAL (RFP)

This request for proposal (RFP) is a request for competitive sealed proposals designed to solicit offers from qualified offerors/contractors who will be responsible for providing scheduled maintenance services on two air compressors, one located at the Mitchell CSMS#1 shop in Mitchell, SD and one located at the Rapid City CSMS#2 shop in Rapid City, SD in accordance with Exhibit A (Scope of Work). Work location is 1215 Industrial Rd, Mitchell, SD 57301 and 1205 E. Catron Blvd, Rapid City, SD 57702.
