1.0 GENERAL INFORMATION

1.1 PURPOSE OF REQUEST FOR PROPOSAL (RFP)

The South Dakota Department of Health (SDDOH), Office of Disease Prevention and Health Promotion is seeking proposals from qualified agencies to provide a full time Cancer Program Outreach Coordinator. This position will work closely with South Dakota's Breast and Cervical Cancer Early Detection Program and Colorectal Cancer Program to provide services that are consistent with the programs' goals, which reflect evidence-based approaches and are recommended by the Centers for Disease Control and Prevention (CDC).

The cost proposal must be in a separate sealed envelope and labeled "Sealed Cost Proposal". The sealed envelope must be marked with the appropriate RFP Number and Title. Proposals must be post marked by Proposal Submission date as referenced in the Schedule of Activities.



All proposals must be signed, in ink, by an officer of the responder, legally authorized to bind the responder to the proposal, and sealed in the form intended by the respondent.
