


GENERAL DEMOLITION NOTES


- 1. GENERAL CONTRACTOR SHALL COORDINATE REMOVAL OF ITEMS BY OTHERS AND SHALL BE RESPONSIBLE FOR CONTACTING TENNESSEE ONE CALL SYSTEM AND AFFECTED UTILITY COMPANIES.
- 2. ALL DEMOLITION AND REMOVAL SHALL BE PERFORMED IN ACCORDANCE WITH THE PLANS AND COUNTY REQUIREMENTS IF APPLICABLE.
- 3. REMOVE ALL ITEMS WITHIN DEMOLITION LIMITS AS SHOWN ON PLANS UNLESS NOTED "TO REMAIN". ALL TREES, SIGNAGE, UNDERGROUND UTILITIES, INCLUDING PIPES, MANHOLES, CATCH BASINS, VALVES, HYDRANTS, CONNECTIONS, AND THEIR MISCELLANEOUS APPURTENANCES SHALL REMAIN UNLESS OTHERWISE NOTED.
- 4. ALL EXISTING GAS, ELECTRIC, TELEPHONE & CABLE TV LINES, POLES, MANHOLES, METERS, VALVES OR MISCELLANEOUS SITE APPURTENANCES TO BE REMOVED, RELOCATED, OR ADJUSTED TO GRADE PER PLAN, SHALL BE DONE BY THE APPROPRIATE UTILITY OWNER.
- 5. CONTRACTOR SHALL REPLACE OR REPAIR ANY ITEM NOT REQUIRED TO BE DEMOLISHED OR REMOVED THAT IS DAMAGED DURING THE PERFORMANCE OF THE WORK. THESE ITEMS INCLUDE, BUT ARE NOT LIMITED TO: PAVEMENT, WALKS, LAWNS, PLANTINGS, AWNINGS, POLES, SIGNS, AND BUILDING FINISHES.
- 6. WHERE PROPOSED WALKS AND CURBS MEET EXISTING WALKS AND CURBS, REMOVE EXISTING WALK/CURB TO NEAREST SCORE LINE.
- 7. AFTER REMOVAL OF ITEMS INDICATED CONTRACTOR SHALL RE-GRADE WITHIN LIMITS OF DISTURBANCE TO MAINTAIN PROPER DRAINAGE.








DEMOLITION LEGEND

WITH APPROVED MATERIAL. COMPACT TO 90%. SEED
